Tell dispatcher: "I have just received a verbal death threat by voicemail and text message from Bri Bosma at 612-716-9997. I have audio evidence and screenshots. I am in fear for my safety."

1. EXECUTIVE SUMMARY

On 2026-08-02 between 4:31 PM and 4:34 PM Central Time, the Reporting Party received an explicit verbal death threat from Bri Bosma via voicemail and SMS to phone number +1 612-716-9997. The threat was delivered in response to the Reporting Party's publication of a consumer-warning website documenting alleged regulatory violations by the subjects' business.

The voicemail contains the verbatim statement: "I'm gonna fucking kill you, bitch." The accompanying SMS contains an extended threat demanding that the Reporting Party "restore our fucking website before you go to fucking prison."

These threats meet the statutory elements of:

- **Minnesota Statute 609.713 (Terroristic Threats - Felony):** Direct verbal threat to commit violence with the purpose to terrorize another.
- **Minnesota Statute 609.749 (Stalking - Felony):** Repeated conduct directed at a specific person causing fear or intimidation.
- **Minnesota Statute 609.2231 (4th-Degree Assault):** Act done with intent to cause fear of immediate bodily harm or death.
- **Minnesota Statute 609.748 (Order for Protection):** Authorizes Harassment Restraining Orders for conduct causing substantial emotional distress.

2. VERBATIM THREAT TEXT

From: Bri Bosma (B contact card visible, +1 612-716-9997)

Date: 2026-08-02, 4:32 PM (Today)

Channel: SMS text message with 31-second voicemail embedded in thread

Verbatim message text:

"Hi, Aladdin, you need to get yourself the fuck out of our lives. I'm gonna fucking kill you, bitch. This is absolutely ridiculous. A, you have no control over this fucking website. You're simply an employee who has now taken advantage of any trust that was given to you, and here you are fucking ruining our lives, and you better bet. You will go down for this. I can promise you that right fucking now. Get yourself out of our lives, restore our fucking website before you go to fucking prison."

Embedded voicemail (.amr file): 31 seconds, 25,046 bytes, AMR (GSM telephony) codec.

Phone call log evidence: At 4:34 PM the Reporting Party received a phone call from Bri Bosma (10 prior calls visible) at +1 612-716-9997. The call was declined. At 4:32 PM, a separate phone call from Evan Bosma is also visible in the call log.

3. EVIDENCE INVENTORY

All files in this package are the originals captured from the Reporting Party's mobile device on 2026-08-02. SHA-256 hashes below establish chain of custody. Any file whose hash does not match this list has been tampered with.

4. FILING INSTRUCTIONS

For the Reporting Party:

1. **If you are in immediate danger, call 911 NOW.**
2. Go in person to Bloomington Police Department: 13820 West 78th Street, Bloomington, MN 55438. Phone: (952) 563-4900.
3. Bring your mobile phone (with original voicemail still in the voicemail system).
4. Bring this entire package - printed or on USB.
5. Request an Order for Protection (HRO) under MN Statute 609.748 against Evan Bosma and Bri Bosma.
6. Request prosecution referral to the Hennepin County Attorney's Office.
7. Do NOT delete the voicemail. Do NOT engage with the subjects further. Do NOT take down the website.
8. Document any further contact. Every subsequent call, text, or approach becomes additional evidence.

For the Officer / Prosecutor:

1. Verify SHA-256 hashes of all files match SHA256-MANIFEST.txt before relying on any file.
2. Subpoena Verizon (carrier of +1 612-716-9997) for original voicemail records, call detail records (CDR), and subscriber information.
3. Request forensic examination of the Reporting Party's mobile device for voicemail system metadata, deleted messages, and call history.
4. Cross-reference this incident with consumer-protection complaints filed by the Reporting Party with FDA, FBI Minneapolis, Minnesota OCM, North Dakota Department of Agriculture, and Minnesota Department of Health. These provide context for motive.
5. Consider Order for Protection under MN Statute 609.748 for immediate protection.

5. CONTEXT & MOTIVE

These threats were made in direct response to the Reporting Party's publication of consumer-warning materials documenting alleged regulatory violations by the subjects' business. The threats themselves are additional evidence supporting the consumer-protection complaints.

Why this happened:

- The Reporting Party worked for Nutrition Excellence LLC from approximately December 2025 through August 2026.
- During that period, the Reporting Party allegedly observed: product substitution between MN and ND markets; falsified or duplicated Certificates of Analysis; unsanitary manufacturing conditions in a commercial office suite with no food-grade sanitation controls; and unauthorized installation of employee-monitoring software (Teramind) on a personal laptop.
- On 2026-08-02 the Reporting Party filed consumer-protection complaints with multiple state and federal agencies (FDA, FBI, MN OCM, NDDA, MN Department of Health) and published a consumer-warning website documenting the alleged conduct.
- Within hours of publication, Bri Bosma and Evan Bosma contacted the Reporting Party with the threats documented in this package.

The SMS explicitly references "this fucking website" and demands the Reporting Party "restore our fucking website before you go to fucking prison." This confirms:

- The Reporting Party's role as a consumer-protection advocate
- The subjects' specific awareness of the public-interest publication
- The motive for the threats (suppression of consumer-protection speech)
- The Reporting Party's status as a witness rather than a personal adversary

6. PRESUMPTION OF INNOCENCE

The Reporting Party acknowledges that all matters described in this report are allegations and that the subjects of the report retain the presumption of innocence with respect to any criminal charges. The subjects may respond to the allegations through appropriate legal channels. This report does not constitute a personal assertion of fact beyond what is documented in the attached evidence.
